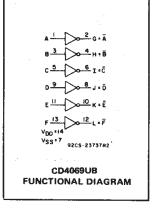

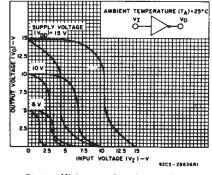


Fig. 1 - Minimum and maximum voltage transfer characteristics

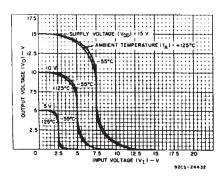
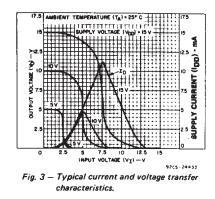


Fig. 2 - Typical voltage transfer characteristics as a function of temperature.

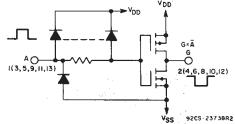


Fig. 6 - Schematic diagram of one of six identical inverters.

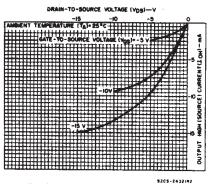


Fig. 9 — Minimum output high (source) current characteristics.

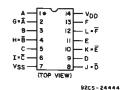
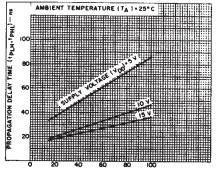
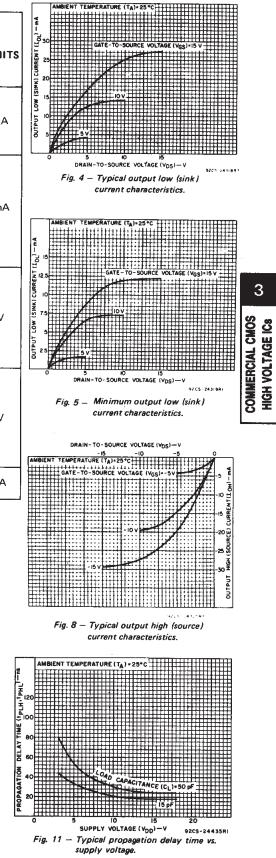


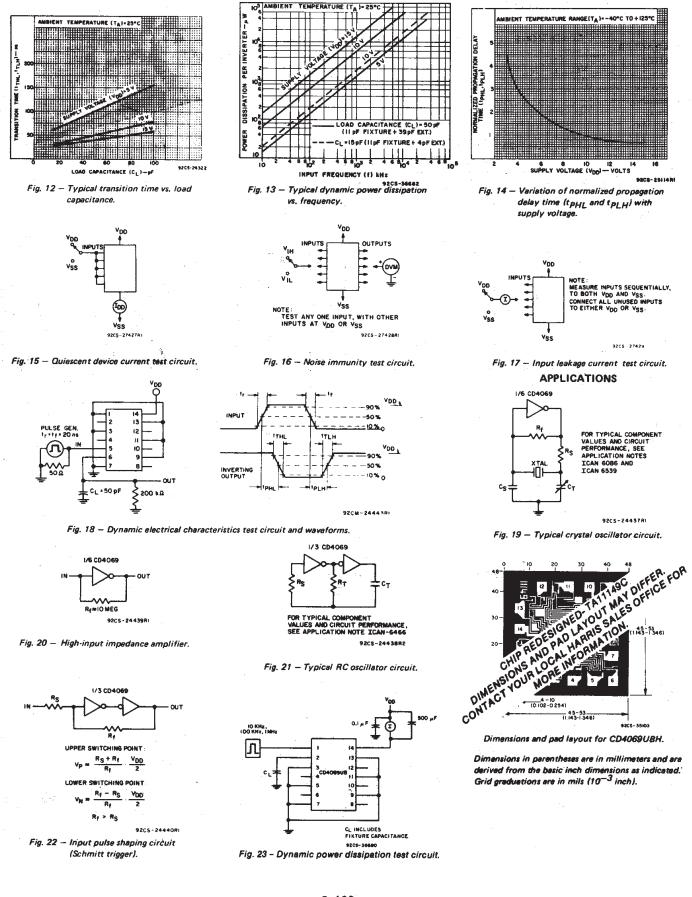
Fig. 7 - CD4069UB terminal assignment.

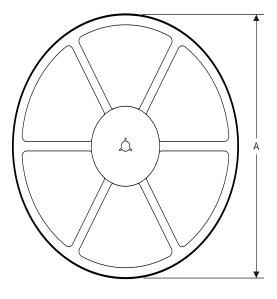

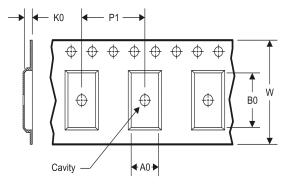
